Subject: NEW FUNCTIONAL STRUCTURE OF WORLD SKATE EUROPE-RINK HOCKEY TECHNICAL COMMISSION

Dear Sirs:

On 2019, February 1 and 2, was held in Porto, Portugal a board meeting of **World Skate Europe-Rink Hockey Technical Commission (WSE-RH)**, with the presence of **Fernando Graça, Lluís Ferrer, Cesare Ariatti, Luís Rei, Ricardo Oliveira e Susana Pandavenes**.

According to the agenda of this meeting, was discussed and approved the new functional structure for **WS Europe-RH**, as well as the new associated working procedures with the affiliated Federations, Clubs and European Referees that enter immediately in force.

1. THE NEW FUNCTIONAL STRUCTURE OF WS EUROPE -RH

1.1 EXECUTIVE COMMISSION & SECRETARY GENERAL

The Executive Commission of **WSE-RH** –that is designated by the *WS Europe President and has the voting rights in any decision of this Commission* - has the following composition:

- **WSE-RH PRESIDENT - FERNANDO GRAÇA** (*Portugal*)
- **WSE-RH 1st. VICE PRESIDENT – LLUIS FERRER** (*Spain*)
- **WSE-RH 2nd. VICE PRESIDENT & SECRETARY GENERAL – CESARE ARIATTI** (*Italy*)

1.2 GENERAL MANAGER AND FINANCING MANAGEMENT

These duties and responsibilities are insured by the **WSE-RH PRESIDENT, FERNANDO GRAÇA** - with the cooperation of:

- 1.2.1 The **SECRETARY GENERAL – CESARE ARIATTI** (*Italy*)


- **MARKETING AND COMMUNICATION**
