Subject: FEMALE LEAGUE CUP – ALLOCATION OF THE 2019 FINAL FOUR ORGANIZATION

Dear Sirs:

According to the deadline and the conditions established in our Communication FG-003/2019 - *relative to the organization of the Final 4 of the Women's League Cup, which will take place on March 16 and 17, 2018* - **WS Europe -RH** received the following two proposals, which were presented to us by the **RFEF - Real Federación Española de Patinaje**:

- (1) A proposal from **HC PALAU DE PLEGAMANS**
- (2) A proposal from **CLUB PATÍ MANLLEU**

Then, and taking into consideration the regulations in force – *as informed in the paragraphs 2, 3, 4 and 5 of Communication FG-004/2015, dated from 2015, February 11* – **WS Europe-RH has decided to award the Spanish Federation and the club CP MANLLEU with the organization of 2019 Final 4 of the Female League Cup.**

7. TICKETS AVAILABLE FOR THE PUBLIC AND FOR EACH ONE OF THE PARTICIPATING CLUBS


- 7.1 As established by the regulation in force, it is necessary to ensure the "neutrality" of the venue for this competition.
- 7.2 In addition, it is also important to take into account the safety standards to be guaranteed throughout the event, in accordance with the specific regulations in force regarding this issue.
- 7.3 Regarding the tickets for the competition, its sale and distribution to the fans of the participating teams must be done according to the following principles and criteria:
 - a) **In each game, the organization will have to ensure - as a "minimum" - that 20% of the tickets issued will be sold to the public;**
 - b) **Each one of the participating clubs may have 40% of the tickets issued for the matches in which they participate, taking into account that:**
 - **For the matches of the semi-finals,** the requisition of the tickets will have to be communicated to the organization until 18H00 of Friday, 9 of March 2019 and their payment will have to be insured until 10:00 of Saturday, 16 of March 2019;
 - **For the match of the final,** the requisition and payment of the tickets will have to be insured to the organization until 10H00 of Sunday, 17 of March 2019.
