Dear Sirs:

According to the information and the deadline established by our Communication FG-007/2019, concerning the organization of the EUROLEAGUE Final 4, to be held on 2019, May 11 and 12, **WS EUROPE-RH has unanimously decided – taking into consideration the regulations in force - to award FEDERAÇÃO DE PATINAGEM DE PORTUGAL, through its affiliated club, SPORTING CLUBE DE PORTUGAL, with the organization of this event.**



1. PLACE FOR THE COMPETITION - RINK AND PREMISES CHARACTERISTICS

- Sports Hall:** **PAVILHÃO JOÃO ROCHA**
Address: Rua Francisco Stomp, 1600-464 Lisboa–Portugal
Size: **40 x 20 meters, with wood surface**
Capacity: **3.000 seated places**
Facilities: **8 dressing rooms for teams + 4 dressing rooms for Referees (2 of them for the Referees), Anti-Doping control room + Press room & Press stand + VIP Executive box + Auditorium + 2 organizational offices + Parking for cars and for buses**

For all the matches, **the designated WS Europe-RH Delegate is FELICIANO COSTA**, from Lisbon.

6. TICKETS AVAILABLE FOR THE PUBLIC AND EACH ONE OF THE PARTICIPATING CLUBS

The sale and distribution of tickets by the participating teams will follow the principles that have been established by the **WS Europe-RH**, in order to **safeguard the "neutrality" of the venue of the matches** in relation to this event. Then:

- 6.1.** For each match, the organization must guarantee that **30% - at least - of the tickets issued must be available for sale to the public.**
- 6.2. Each club will be entitled to request to the organizer 368 tickets - at most - issued for any match in which it participates**, taking into consideration the following constraints:
 - 6.2.1** The **tickets for each Semi-Final must be requested and paid until 18H00 of Thursday, 2019, May 2.**
 - 6.2.2** The **tickets for the Final must be requested and paid until 23H59 of Saturday, 2019, May 11.**

Note: The organizer will offer 20 invitations to each participating team, for each match of this competition.


