Subject: 38th. MALE U17 EUROPEAN CHAMPIONSHIP – RETIFIED CALENDAR & ADDITIONAL REQUEST FOR INFORMATION

Dear Sirs:

The **FPP-Federação de Patinagem de Portugal** submitted a complaint to **WS Europe-RH** regarding the calendar published yesterday by our official Communication FG-016/2019, bearing in mind that – *as has been the norm in the various competitions already organized* - the organizing entity wants that – *with the exception of the Final match, if it is the case* – all of its games will be scheduled as the last game of each journey.

2. Accordingly, WS Europe-RH unanimously ruled that FPP's claim was entirely fair and relevant and it was decided:

- 2.1 **To accept the FPP's claim and make the necessary adjustments to the schedule already disclosed**, both with regard to the First Phase and – *as the case may be* – with regard to the second phase of the competition, except for the ordering of the games of the last day.
- 2.2 Accordingly – *and taking into account any additional changes that may be required as regards the Portuguese matches in the second phase of the competition* – **it was approved the following CALENDAR RECTIFICATION OF THE FASE 1 OF THIS COMPETITION:**
