## PROVISIONS AND REGULATIONS EUROPEAN COMPETITIONS CLUB 2020-21 COVID-19 MANAGEMENT

### 1. PROVISIONS COVID-19

- This document aims to be an updated verification tool, to guarantee the possibility to plan and manage to carry out the European Competitions 2020-2021 activities.
- We must All be aware that in any moment of the season, the carrying out of the activities can be interrupted, if a the Covid-19 infections reappear, in our sport field, in the relevant sport club, in the entire community and in the participating Nations.
- It is necessary to have a clear understanding of the circumstances that could bring to:
  - postpone the matches,
  - a suspension of the matches,
  - temporary cancellation of the competitions (three different competitions that could have different progress),
  - the suspension of the competitions,
  - a change in how the competition takes place, in order to allow its conclusion.
- This will depend on, apart from the possible health emergencies in the participating nations, above all on the differences of the national provisions, regional and local of every Club enrolled in the competitions.

## 2. NATIONAL FEDERATIONS

Every Sport Federation , must send to the WSE Committee the following documents, updated underlining the provisions which interest the ongoing of the Sport Competitions.

- Covid-19 Government Provisions
- Federal Protocols and Provisions for the Skating/Rink Hockey
- Send a Form with the general information of the Covid-19 Federation Referent (form 1)
- Send a Form with the general information of the Head of the Federal Medical Commission (form 2)
- Send the form with the general information of the National Referees Responsible (form 3)

The WSE european Committee will appoint a **Covid-19 WSE referent**, who will be the interlocutor for the Federations and Clubs

- As for Covid-19 Protocol of the WSE Committee, the Federations must send the generalities of the Covid-19 Federation Referent. (Attached form)
  - **Referent Federation Covid-19**: he will be the interlocutor for the WSE European Committee, in the 2020-2021 season.
  - **Head of the Federal Medical Commission**: he will be the interlocutor for the WSE European Committee, in the 2020-2021 season.
  
- As required by the WSE Committee of the Competition Regulations, the Federations must send the generalities of the National Referees Responsible
  - **National Referees Responsible**: he will be the interlocutor of the Referee area, for the WSE European Committee, in the 2020-2021 season

### 3.

#### CLUB

Every Club participating to the European 2020-2021 competitions, must send to the WSE Committee the following updated documents, underlining the provisions which focus on the sport competitions execution.

- Local Provisions
  - Regional Provisions
  - Covid-19 Sport Facility Protocol
  - Send a form with the generalities of the Covid-19 Officer, the only Club Referent (form 4)
  - Send a form with the Team Hygiene Officer generalities (form 5)
- As required by the Covid-19 Protocol of the WSE Committee, the Federations must send the **Covid-19 Officer** generalities
- **Covid-19 Officer:** every Club must elect a Covid-19 Officer who will be responsible for guarantiing that all the mitigation measures are followed by all players, team and game officials and by all the staff involved in the match. this person must possess the knowledge to carry out the procedures and the protocols set. This person will interact with its Federation and with the WSE European Committee. (Attached form).

The European WSE Committee, the Federations and the Clubs, as required by the Protocol, will interact among them, giving all the useful information, to guarantee the carrying out of the European Competitions.

## TEMPORARY REGULATIONS OF THE 2020-21 EUROPEAN COMPETITIONS COVID-19 EMERGENCY

### PREMISE

The European WSE Committee, viewed the situation conditioned by the COVID-19 emergency makes use of the faculty of carrying out any variation regarding the 2020-2021 sport competitions activities, according to the situations that will occur.

### 1) TRAVEL AND LOGISTICS

- The participating Clubs to the European Competitions will receive immediate information on all the due measures to enter and exit the country without quarantine and/or other restrictive measures, on the competition to be disputed away, both from Hosting team Covid-19 Officer, from the WSE Committee, respecting the WSE protocol provisions.
- The teams that must organise the transfer are obliged to verify which are the Covid-19 provisions, regarding the Airlines and transport, and the Hotels. This in order to know in detail the rules in case of postponing or cancelling of the transfer.
- The Clubs are advised to open an insurance policy, in case events take place, which are not considered in the provisions.

### 2) REFERRAL REQUEST

A club can ask for a game referral in the calendar when the following have been notified :

- Restrictive measures towards at least 4 players, who are put in the 002 Form - Team Players Formulary, within 14 days before a match.
- The game referral request must be sent to the WSE Committee within 24 hours following the communication of the Athletes restrictive measures, together with the documents released by the Health Authorities.
- The WSE European Committee will suspend the match and will inform all the interested parts.
- Mandatory tests that are carried out in the various countries in or out. The WSE European Committee, in agreement with the Clubs, will individually check each situation and then make a decision on it.

### 3) REFERRAL FROM LOT TO AUTHORITY'

The WSE European Committee will arrange the REFERRAL of the game every time there will be a National, regional or local Authority provision activated which will concern :

- Restrictive measures for one of the teams.
- Restrictions of the areas interested by the carrying out of the match.
- Sport Facility closure and there is no possibility to carry out the match in a near by facility .
- Limitations in the movement to such extent that the match carrying out is compromised.
- In all the countries where a quarantine is expected at the arrival or returning from a referral

### 4) THE GAME IS PLAYED

The game will take place regularly :

- In the event that the public authorities decide that competitions should be held behind closed doors, the scheduled match will take place regularly.
- If a Club cannot carry out a match in its Facility, due to Covid-19 restrictions which interest only its area, or region, will have to give an alternative facility of the same country which is not under restrictions.
- If there is no trainer or delegate, attaching the restrictive measures certificate from the Health Authority.

### 5) RECOVERY MATCHS

The WSE European Committee, to plan the recovery of the postponed matches, will interact with the Federations, with the Clubs involved to plan the recovery dates of the match

## 6) REFEREES INTERNATIONAL

The WSE European Committee, considering the situation linked to the pandemic, will prepare an emergency plan regarding how to use the international referee during the 2020-2021 season.

- The European Committee will interact with the Designating Referee of each Federation in order to plan and guarantee the presence of Referee, in the respect of the ongoing rules.
- As required by regulation the international Referee will be summoned for the scheduled matches.
- The WSE European Committee, to remedy sudden emergencies or arrangements occurred applied by the National, Regional or Local Authorities, such as :
  - flight cancellations,
  - travel restrictions or prohibitions,
  - positivity test,
  - quarantenes, adopted by European countries.

which could impede the arrival of the Referees in the designated site.

### **DISPOSES THAT**

- for every day scheduled on the European Competition Calendar, apart from the summoned Referee for the match, one or two international Federation referees belonging to the Club, playing at home, must be summoned as Reserve
- In case the situation does not allow the referees to reach the destination, according to what the WSE Protocol expects, it has been comunicated in due time, international referees of the Federation belonging to the Club of the home team will be summoned.
- This solution will be adopted every time it will be necessary and it will concern all European Competitions.
