European Federations,

The European Committee has issued the following documents in view of the situation affecting the Covid-19 emergency:

- **Guidelines for European Club Competitions 2020-21**
The current document has been written with the aim to give recommendations and general requirements which will have to be applied for the planning and the carrying out of the Club European competitions.
- **Provisions and temporary Regulation European Club Competitions 2020-21 Emergency Covid-19**
This document aims to be an updated verification tool, to guarantee the possibility to plan and manage to carry out the European Competitions 2020-2021 activities.

For this reason, the European WSE Committee, will constantly monitor the evolution of the situation related to the pandemic Covid-19, in close cooperation with the National Sport Federation and e their affiliated clubs, participating to the European competitions.


