1 - Closing PRE-REGISTRATION / OPENING FINAL REGISTRATION

2 - As there are pre-registrations of clubs in THE EUROLEAGUE, but that in view of the regulated ones are not provided in the respective competition, they were included in the WS EUROPE Cup. Thus, they must now make their regularisation if they wish, in the competition in which they were considered.

2.1 - If after July 25, 2021, there are still vacancies for the filling in the EUROLEAGUE, for a total of 16 vacancies and according to the SHARES of point 6, the clubs that have formalized the definitive registration, but only after information by this Committee of WSE-RH, with additional payment of the differential between the two competitions, are formally enrolled.

2.2.1 - Between the dates of July 26 and July 31, 2021, this entire process of regularization of point 2.1., will take place.

3 - Any formalization of the DEFINITIVE registration shall be considered as such only if the settlement of the same by means of a bank transfer has been regularized and the proof of the same has been sent to this WSE-RH committee, until the days referred to above and which are listed below again:

- **July 25, 2021** - **DEFINITIVE Registration**
- **July 31, 2021** - **Registration resulting from RECAP**

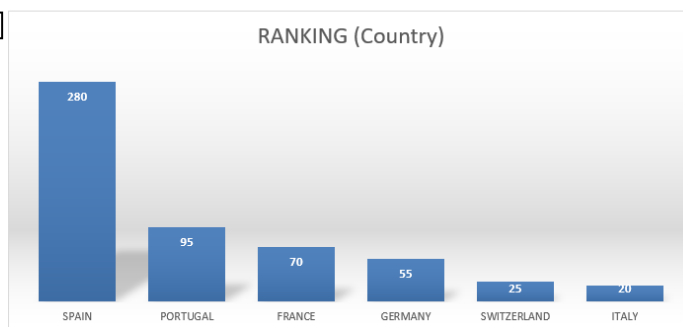
